

Proclamation on information and content services with integrated assessment

Ver. November 21, 2001 Dated July 1, 2004

Generally

Premium Rate Numbers are available only for companies registered in Denmark. To offer this service kwak Telecom has opened and registered an office in Raadhusplaadsen 16, 1550 Copenhagen, Denmark.

The national Carrier, Telecom Denmark (TDC) is the only provider offering Premium Rate Numbers. TDC has chosen to provide only the following number series:

- Category I number series 9013
- Category V number series 9050
 - Category VI number series 90565 9055

TDC must accept the content of service prior to implementation. TDC is obliged to continuously supervise the observance of this proclamation.

TDC is obliged to start all calls with a voice message informing the caller about price/minute of the call incl. taxes. Moreover, it must inform that the service is on TDC network.

Sending of data by modem or fax does not require notification.

After the voice message, the call is forwarded to the provider, who should initiate the call after a 5 sec. pause. It is not required that the pause should be "silent".

- *Chat-lines:* Services provided within category I (9013), can not consist exclusively of forwarding to, or connecting of, two or more end-users.
- *Collections:* Provided in Category VI in the number series 9056 5xxx and 9055 xxxx, this category is allowed only for public utility fundraising collections.

The price offered, incl. traffic is Dkr. 50, 100 or 150 in the 90565-series, and Dkr. 3.75 - 7.00 - 9.00 - 11.00 - 21.60 - 32.00 in the 9055-series.

The provider must be licensed for collections according to Assessment Law § 8A stk. 2 or § 12 stk. 3

Competitions: Provided in the categories V (9050) and VI (90565-9055).

In category V, the competition must constitute the primary part of the service.

Maximum one call per day can be made from the same telephone number to the same 905-number.

Other Providers:

The majority of other providers, especially the big ones, have signed the traffic agreement with TDC. This implies that their users have the option to call 900-services in the TDC network – but it is up to the individual provider whether they have implemented, or will implement, the option. Be aware that not all providers implement the option! As of May 1, 2003 it is not open from TDC Mobil to 905-number.
